GENERAL ORDER #3 REGARDING CHAPTER 12
FAMILY FARMER REORGANIZATION

In all cases arising under Chapter 12 of the United States Bankruptcy Code which were filed prior to this date, an Order to Attorney for Debtor-in-Possession and Notice of Chapter 12 Procedural Requirements was mailed to the attorney for the debtor. The Order contained language in Section 3(b), which states:


- b. All of the debtor's bank accounts must be closed immediately upon the filing of the chapter 12 petition, and new bank accounts opened. All amounts from the old accounts and all receipts are to be deposited in the new bank accounts, and all disbursements should be made by check. The new bank accounts must be in the name of the debtor as "chapter 12 debtor-in-possession," and this description should also appear on the new bank pre-numbered blank checks and deposit slips for his checking account.

IT IS HEREBY ORDERED that Section 3(b) of the Order to Attorney for Debtor-in-Possession and Notice of Chapter 12 Procedural Requirements be changed to delete the last sentence of the section, in all cases prior to the signing of this Order. Thus, the Order shall read:


- b. All of the debtor's bank accounts must be closed immediately upon the filing of the chapter 12 petition, and new bank accounts opened. All amounts from the old accounts and all receipts are to be deposited in the new bank accounts, and all disbursements should be made by check.

IT IS FURTHER ORDERED that, henceforth, the Order to Attorney for Debtor-in-Possession and Notice of Chapter 12 Procedural Requirements shall contain no requirement that "chapter 12 debtor-in-possession," shall appear on blank checks and deposit slips for the debtor's checking account.
